



Student Order Form/Purchase Agreement

In order to be eligible for student discounts on Autodesk and Discreet® software, you must fill in the required information below and present the form to your Autodesk education reseller:

Section 1: Qualifications

I certify that I am a degree-seeking student or a faculty member (as checked below) at the institution stated, and that I am purchasing the Autodesk/Discreet Software for my own personal use for education purposes only and not for commercial or institutional use.

- Degree-seeking student: I am a registered student who can confirm current enrollment in three (3) credit hours in a degree-granting program or who can confirm current enrollment in a nine (9) month certificate-granting program.
- Faculty (full-time or part-time): I am currently employed for a state accredited education institution.
- K–12 Student: I am a registered K–12 student who can confirm current enrollment.

Section 2: The Software License Agreement

I agree that if I open the sealed software media pack, I will be bound by the terms and conditions of the Software License Agreement included online or in the product box. In particular, I understand that I cannot sell, transfer, modify, or copy the Autodesk/Discreet Software. I agree that the software license I have purchased is for education use only. Commercial use of this product will immediately terminate my right to use the software. Though functionally identical to software used by professionals, the educational version of Autodesk/Discreet software may contain the following features that differentiate it from the commercial version: education-specific hardware or software lock, on-screen and printing features that identify the software as an “educational version,” and a limited term license.

Section 3: Upgrades and Education-to-Commercial Transfers

Autodesk/Discreet Student Software upgrades are available for academic career (perpetual) and two year term licenses only, excluding AutoCAD LT. Current student status is required to purchase Autodesk Student software upgrades. Education-to-commercial transfers are available for academic career and two-year term licenses. All other term licenses do not qualify for upgrades or education-to-commercial transfers.
